Other projects may be added in the future if both parties agree to collaborate. The scope and procedural details of the Memorandum are as follows:

- Short-term courses implemented in local communities to educate the general population on green technologies and products
- Transnational experiment exchanges and cooperation
- Joint publication in an international journal
- Application for international funding on green projects
- Solutions for regional issues
- Industry-academia collaboration
- International company internship
- Interdisciplinary talent cultivation
- Assistance in Research and Development, Technology Innovation, Production, and Sales
- Other activities that are deemed appropriate by mutual consent from both parties

### Article 2

Both parties shall describe financial arrangements and stipulations concerning the cooperation in project finance in detail in separate addenda.

### Article 3

Modifications or amendments to this Memorandum shall be only done by mutual written consent.



### Article 4

This Memorandum will enter effect from the date duly signed by both party representatives. The effective period is five years and shall be extended automatically if neither party expresses the intention to terminate or modify this Memorandum. Suppose either party wishes to terminate this Memorandum. In that case, the terminating party shall provide a written notice to the other party three months before the specified termination date.

#### Article 5

Both parties shall first attempt to resolve any dispute arising from or relating to this Memorandum Of Understanding through discussion and negotiation between the parties acting in good faith.
